Effective February 24, 2025 through April 11, 2025
Amended 3/4/25

ROADS POSTED FOR HEAVY LOADS PER WELLS CODE CHAPTER 212.4 (gross registered weight of over 23,000 lbs.)

Truck traffic over these weights is prohibited on the following roads:


